## AUSTRALASIAN AND PACIFIC OMBUDSMAN REGION 2023 CONFERENCE

The Australasian Pacific Ombudsman Region (APOR) held a conference on 31 October and its 35th annual Members' meeting on 1 November 2023 in Melbourne, Australia.

The conference, themed *Through The Ombudsman Looking Glass: Now And Into The Future* was hosted by Victorian Ombudsman Deborah Glass OBE as Regional President.

Among other topics the conference explored the role of an Ombudsman in a crisis, noting the Ombudsman has a vital role to play in ensuring balance – understanding that governments may need to act decisively and swiftly, but must always be proportionate and responsible and have due consideration to maintaining human rights.

It coincided with celebrations to mark the 50th anniversary of the Ombudsman in Victoria. APOR members noted the significant contribution of the Victorian Ombudsman to the Victorian community over this period and commended their demonstrated integrity and independence.

APOR Members reflected on and reaffirmed their commitment to the Principles on the Protection and Promotion of the Ombudsman Institution adopted by the Venice Commission on 15 March 2019, and the Resolution adopted by the United Nations General Assembly on 16 December 2020, in particular noting:

- The importance of independent and autonomous Ombudsman institutions to improving public administration and ensuring fairness
- The role of the Ombudsman in the promotion and protection of human rights, good governance and the rule of law.

Noting the mandate for the promotion and protection of human rights, APOR Members also acknowledge the importance of supporting the rights of First Nations and Indigenous people. Ombudsman throughout the region have an important role to play in empowering those aggrieved by the actions of government agencies and supporting their human rights.

The Workshop, facilitated by the NHRI Team on October 31, 2024 preparing the A'ana No. 1 Committee and Fonofa'avae Office bearers with their first Community-Led Pilot Project scheduled before the end of November 2023. Participants were introduced to the legislated functions of the Ombudsman Office; Human Rights principles; and particularly on these premises are compatible with the Fa'a-Samoa and Christian values.

Learnings from the workshop would build the capacity of the District Committee members on how to conduct their first ever Community-led project. The Human Rights Community-Led Development (HRCLD) project for Samoa, Cook Island and Fiji is funded by the Asia Pacific Forum. In effect and as for Samoa, the A'ana #1 Pilot Project is in Phase 2-Capacity focusing on building capacity for the District Committee, before implementing the main Human Rights Community-led engagement which is Phase 3.

# HUMAN RIGHTS COMMUNITY-LED WORKSHOP PROJECT

## FONOFA'AVAE A'ANA NO. 1

This pioneering Community-Led Workshop Project for A'ana No. 1 has been in the pipeline with the NHRI Team spearheading the development of the Community-Led Pilot Project from Phase 1 to Phase 3. In effect Phase 3 is the actual implementation of lessons learnt from a relative pre-training workshop on Human Rights as conducted entirely by the A'ana No. 1 Committee with the Office as observer.

A brief traditional welcome was extended to the Office by representatives of A'ana No. 1 and the Fono Mua Fonofa'avae Office. The Ombudsman Office in reciprocation acknowledged the leadership of the A'ana No. 1 particularly the Fono Mua District Office for taking the lead towards examining specific Human Rights challenges faced by the people of the District.

The two-day Community-led Workshop in a word allows the local facilitators to lead the entire program whilst the participants to raise relevant discussions on human rights matters that are at least observable across the A'ana No. 1 district. Also participants being the people of the district were seen as very familiar with the facilitators making their interactive participation more lively and meaningful. once more we sincerely acknowledge and congratulate the Fono Mua District Office of A'ana No. 1 for your remarkable support and the successful partnership with the NHRI & Office of the Ombudsman. ## FOLLOW-UP VISIT BY THE UN COMMITTEE ON THE RIGHTS OF THE CHILD (CRC84)

A Senior Supreme Court Judge Vui Clarence Nelson has promptly stressed that: ... *violence isn't discipline, its abuse*". Further, the Judge pointed out that the prevalent practice of: *using violence to discipline children is abuse*. Justice Vui Clarence Nelson attended a conference, as part of a follow-up visit by the UN Committee on the Rights of the Child (CRC84). The conference was held for three days at the Taumeasina Island Resort Conference Room.

In a media interview, Justice Vui stressed that with the many cases going before the courts on a daily basis, he was disheartened by the rise in cases of violence against children. *"There are obviously many challenges in our communities and heaps of violence (cases) in families which is not decreasing especially with our knowledge from the side of the Court,"* remarked the Senior Supreme Court Judge. *"Many cases involve children and it keeps going up and it's really disheartening. When will the violence stop against our children in terms of sexual violence and sexual abuse, especially within our families? I am really sad with how this is still happening."*

One of the many cases that remains heart-wrenching for Justice Vui is the number of cases involving young girls being sexually abused within their own homes which he stressed is also on the rise. *"As I said, the numbers keep growing on such cases and it's really sad to keep seeing this being reported to the courts,"* he added.

The Senior Supreme Court Judge was the first Pacific Islands Judge to be appointed to the UN Committee on the Rights of the Child in 2014. In 2018 he was re-elected for another four-year term on the UN Committee and served as its Vice Chairperson and the Coordinator of the Working Group on the Optional Protocol on a Communications Procedure before his second term ended last year in 2022.

In celebration of the lead up to the annual Human Rights Day on December 10 2023, the Office in collaboration with the United Nations Office carried out a program mainly to revitalise human rights awareness with a focus on the Right to Education in Samoa. Opening remarks by the Acting Ombudsman, Mauaiaivao Pepe Seuli touched on the mandate of the National Human Rights Institution (NHRI) which was housed under the Ombudsman's Office since 2013 and how it aims to promote and protect the human rights of all people in Samoa.

Further, the United Nations Resident Coordinator Mr. Themba Kalua spoke on the importance of this event in creating awareness for our people and also in celebrating the 75th anniversary of the signing of the Universal Declaration of Human Rights this year. He addressed the role of his office in supporting the NHRI and other partners in ensuring that education is accessible for all.

Furthermore, MESC CEO Afioga A'eau Chris Hazelman remarked that in days like today we are to be reminded that education is not a privilege but a human right. He further expressed that our people must also understand that education does not firstly happen in schools and universities, but rather, that it begins within our homes and families.

Finally, afioga A'eau elaborated on the idea that: "An intelligent person with an excellent educational background means nothing if s/he lacks ethics and values. *"With respect as in my own view, Samoa does not need more academic education but more basic values,"* A'eau reaffirmed.

A rather moving short film titled CHANGEMAKERS was shown, and this highlighted the life of a deaf young woman, Maselina Iuta and her extraordinary journey towards acquiring access education. Reflections by the panel members and also the participants were exchanged in respect of the same. The second half of the event was the prize giving for a nationwide Poem and Tik Tok competition launched by the Office earlier in the month which focused on the Right to Education.

We congratulate all the winners of these competitions and also thank those who have contributed and participated in our activities to celebrate Human Rights Day 2023.



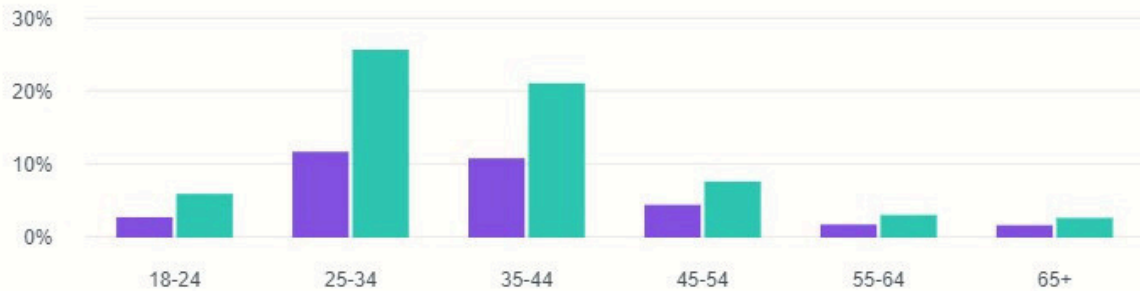
